Dear Valued Customer:

Sysco's Specialty Meat Group (SSMG) meat and poultry facilities all operate under CFIA (Canadian Food Inspection Agency) or USDA Food Safety Inspection Service (FSIS) meat and poultry inspection requirements. As such, all products processed or repacked at our establishments have a unique establishment number assigned to our plants by CFIA or FSIS. Those numbers are listed below next to the name of each location. The numbers will be preceded by an EST abbreviation and either be in the CFIA or USDA Inspection Legend itself or referenced in the inspection legend and printed on the packaging weight label.

By use of this number and the CFIA or USDA Inspection Legend, our customers can be assured of the origin of our products as being processed at the indicated Establishment. Use of the CFIA or USDA Inspection Legend and Establishment Numbers falls under federal regulatory requirements and misuse of the Legend or Establishment Numbers is a violation of federal law.
