Dear Valued Customer:

Sysco's Specialty Meat Group (SSMG) utilizes only meat and poultry raw materials that are subject to the USDA FSIS Residue Detection System and CFIA National Chemical Residue Monitoring Program relative to antimicrobial, pesticide and hormone products. Under these programs, the CFIA, US Department of Health and Human Services, FDA and USDA FSIS have established strict tolerance levels for these components in consultation with Health Canada or the US EPA, as appropriate. US tolerance levels are published in various location in Title 21 of the US Code of Federal Regulations. FSIS has a strict product testing protocol for compliance with the Residue Detection System, and that protocol includes regular testing to cover all domestic and imported product under their authority, including raw beef, pork, lamb, veal and poultry. Canadian establishment monitoring is under the supervision of CFIA veterinarians. Inspectors test for residues in a random sampling plan. That plan and tolerances are outlined in the CFIA National Chemical Residue Monitoring Program. Facilities must complete acknowledgement forms that producers sign indicating compliance with the requirements for animals to be meet human consumption residue limits when they are harvested.

In keeping with our values of providing our customers with a wide array of products that meet their demand, SSMG locations source from a large pool of source products. Included in those sources are certain supplier controlled programs that, among a variety of different claims related program requirements, include products from livestock and poultry raised without the addition of hormones and raised without added antibiotics requirements. Those products are available upon specification by our customers and subject to supply availability.
